ABSTRACT

Agricultural credit supports to the livelihood of farmers through increasing the productivity and profitability of agriculture. The present paper analyzes the performance under priority sector advances to agriculture sector, recovery performance under priority sector advances; target achieved under priority sector advances to agriculture sector, bank-wise credit disbursement performance and demand and recovery performance. Study finds that, financing to agriculture sector was somewhat positive in nature but the trend was declining in recent years.
